



Principal Newsletter Report

21st November 2025

Unit 4 VCE exams concluded this week at the Lutheran Hall, and I received some excellent feedback from our examination supervisors about the way in which Year 11 and 12 students have tackled their written exams over the past fortnight; it has been very pleasing to observe lots of exam preparation happening at school, and at home. **VCE results this year will be released to students electronically on Thursday 11th December from 7:00am onwards**, and hardcopy results will arrive in mailboxes in the days after this date. I wish all our VCE students well with their results - they have certainly worked hard in their studies across the year.

On Wednesday evening we celebrated the graduation of our 2025 Year 12 VCE group at the Hawkesdale Memorial Hall, and the effort and perseverance that is required to successfully finish thirteen years of primary and secondary education. **The Year 12 Graduation Dinner** is one of the highlights of the school year, and I felt very proud to hear our School Captains - Heath and Lillian - reflect on their memories and appreciation of our school in shaping their schooling journey.



I note that a number of families have a youngest child graduating from Year 12 this year. I would like to thank the Boyd, Hibbert, Hutchins, Johnston, Leske-King, Triance and Thomson families for their involvement with our school over the years, and to wish them all the best into the future. Guiding students through their schooling is an important partnership between the teachers, students and parents, and I am always grateful for the efforts that families make to ensure that children are present at school and fully supported in their learning. A big thanks particularly to Ms White for her role in organising the Year 12 Graduation Dinner this year, and to Mr Kingston for making a flying visit back to Hawkesdale to wish the Year 12's all the best with their future endeavours.

Well done also to our busy Parents and Friends Club for their involvement in purchasing decorations and photo backdrops for the Year 12 and Year 6 graduation ceremonies that will occur this year; the Memorial Hall looked fantastic! Our P&F also arranged for the design and ordering of graduation stoles for each of our Year 12's - a new tradition for our school, and one that was well-received and looked very stylish. Thank you!

The recall of kinetic sand products has received extensive media reporting and consumer alerts over the past fortnight, with school closures happening in other states and territories. At our school, we are taking the steps set out by the Department of Education to collect and dispose of any kinetic craft sand products that may be in classrooms. Current advice from national and Victorian health authorities is that there is a low risk to human health from craft sand products that may contain asbestos. If you have the product at home however, the advice from health authorities is that you should stop using it and follow online ACCC product safety advice; the online link can be found in the Compass email that I sent to all families earlier in the week. Please contact me at school if you would like to discuss anything to do with this issue.



It has been pleasing to observe secondary students training at lunchtimes using our set of school mountain bikes, preparing their riding and fitness skills for the upcoming Great Hawkesdale Bike Ride. The GHBR this year will use the vehicle-free surface of the Port Fairy to Warrnambool Rail Trail, and as always there will be overnight camping and lots of fun for the riders involved. A rest day is available for students who take part in the ride on Friday, December 12, with classes still happening at school for all other students on this day.



A reminder to families that from 1st January 2026 children and young people aged under 18 can travel free on all Victorian public transport services - this includes trams, trains, buses and coach services across the state. A new tap-on/tap-off Youth MYKI card has been developed to allow for this free travel, and more information will be available as to how these cards can be accessed later in the term. Regional travellers will need to show their cards on services that do not feature MYKI readers. Reduced Vline ticketing costs have been a great saving for our metro-based camps and excursions, and this latest travel initiative from the Victorian government will continue to assist our families financially with statewide travel.

Following on from feedback from the Strategic Review process earlier in the year, I am planning to restructure our school timetable in 2026 to maximise teaching and learning opportunities at our school. We currently operate within a 30-period week, with students taking part in 6x50 minute sessions each day. In 2026, we will begin the year with 5x one hour period days, with students having 25 subject sessions for the week. One of the significant advantages created by this change will be to allow our primary students to have access to the recommended two hours of literacy instruction every day, as well as one hour of numeracy instruction every day. Building primary literacy and numeracy skills will translate to improved secondary literacy and numeracy skills as students move through year levels and will have the capacity to lift the academic performance of all students over time. This will be very different way for our school to operate, and we will use 2026 to monitor and assess the scheduling of subjects to create the best model possible for future years. While start and finish times will not change in 2026, recess and lunchtime will be a little later, with 2x hour sessions happening before recess, 2x hour sessions happening before lunch, and then a single hour-long period happening after lunch to finish the day. I will share the new weekly schedule with our community via the newsletter next week - please let me know if you would like to discuss this further.

Finally, there is some more great woodwork and design work on display in our Admin foyer this week, with our Year 7 class creating a range of clever coin boxes using layered plywood and perspex. The quality of this work is excellent - well done Mr Hoeksema and our Year 7 students!

- If I withdraw my consent or do not alternatively provide proof of my circumstances/details, I may not be eligible for the Camps, Sports and Excursions Fund provided by DE.
- Information regarding my eligibility for the Camps, Sports and Excursions Fund may be disclosed to DFFH and/or State Schools Relief for the purpose of evaluating concession card services or confirming eligibility for assistance.

## Camps, Sports and Excursions Fund eligibility

Below are the criteria used to determine a student's eligibility for the Camps, Sports and Excursions Fund (CSEF).

### Criterion 1 – General eligibility

The applicant must be one of the following:

- a parent or carer who is the beneficiary of a financially means-tested card.
- a student over 16 years who is considered a mature minor and holds a valid concession card (such as a Youth Allowance Health Care Card or Disability Support Pension Card). For guidance on assessing whether a student is a mature minor, refer to the department's policy on [Mature Minors and Decision Making](#).
- A parent or carer whose child is 16 or over and the beneficiary of a financially means tested card but are not considered a mature minor.

Applications must be submitted to the school by the end of Term 2.

Where the parent or carer is seeking eligibility based on an eligible financially means-tested card, eligibility will be determined when the relevant concession card successfully validates with Centrelink on either the first day of Term 1 or Term 2.

For students over 16 years of age and where the eligible card is in the name of the student, the fund is only granted to that student, not their siblings.

### Criterion 2 – Be of school age and attend a Victorian school

For the purposes of CSEF, students may be eligible for assistance if they attend a registered Victorian school.

CSEF is not payable to a student attending pre-school, kindergarten, TAFE or who are home schooled.

### Eligible means tested cards

### Eligibility date

For concession card holders, CSEF eligibility will be subject to the parent/carer's concession card being successfully validated with Centrelink (see [Camps, Sports and Excursions Fund \(CSEF\): Policy | education.vic.gov.au](#)).

### Payment amounts

CSEF is an annual payment paid directly to the school and will be allocated by the school towards camps, sports and/or excursion costs for your child. Please refer to the policy for the current rates.

**For ungraded students**, the rate payable is determined by the student's date of birth. For more information, see: [Camps, Sports and Excursions Fund \(CSEF\): Payment amounts | education.vic.gov.au](#)

**Foundation and Year 7 government school students** who are CSEF recipients are also eligible for a uniform voucher. Schools are required to make applications on behalf of parents, so please register your interest at the school.

### How to complete the application form

**Note: all sections must be completed by parent/carer**

1. Complete the PARENT/CARER DETAILS section.  
Make sure that the Surname, First Name, and Customer Reference Number (CRN) details match those on your concession card. You will also need to provide your concession card to the school.  
If you are claiming as a Foster Parent a letter of support from the institution facilitating the arrangement (for example Mackillop Family Services) or the Department of Families, Fairness and Housing (DFFH) is required as evidence. If you are claiming a Veteran Affairs Pensioner, you will need to provide a copy your Veterans Affairs Pensioner Gold card.
2. Complete the STUDENT/S DETAILS section for students at this school.
3. Sign and date the form and return it to the school office as soon as possible.

CSEF payments cannot be claimed retrospectively for prior years.

**Queries relating to CSEF eligibility and payments should be directed to the school.**

# FINANCIAL ASSISTANCE

## INFORMATION FOR PARENTS

**Every Victorian child should have access to the world of learning opportunities that exist beyond the classroom. The Camps, Sports and Excursions Fund helps ensure that no student will miss out on the opportunity to join their classmates for important, educational and fun activities. It is part of making Victoria the Education State and the Government's commitment to breaking the link between a student's background and their outcomes.**

### CAMPS, SPORTS & EXCURSIONS FUND (CSEF)

School camps provide children with inspiring experiences in the great outdoors. Excursions encourage a deeper understanding of how the world works while sports teach teamwork, discipline and leadership. All are a part of a healthy curriculum.

CSEF is provided by the Victorian Government to assist eligible families to cover the costs of school trips, camps and sporting activities.

If you hold a valid means-tested concession card or are a temporary foster parent, you may be eligible for CSEF. A special consideration category also exists for asylum seeker and refugee families. The allowance is paid to the school to use towards expenses relating to camps, excursions or sporting activities for the benefit of your child.

The annual CSEF amount per student is:

- \$400 for primary school students
- \$400 for secondary school students

#### HOW TO APPLY

New applicants should contact the school office to obtain a CSEF application form or download from the website below.

If you applied for CSEF at your child's school last year, you do not need to complete an application form this year unless there has been a change in your family circumstances.

You only need to complete an application form if any of the following changes have occurred:

- **new student enrolments:** your child has started or changed schools this year.
- **changed family circumstances:** such as a change of custody, change of name, concession card number, or new siblings commencing this year.

# Social media age restrictions: A guide for parents and carers



From 10 December 2025, age-restricted social media platforms will have to take reasonable steps to prevent Australians under the age of 16 from creating a social media account or continuing to use an existing account. The new social media age restrictions are intended to keep young people safe from digital harm. While this is a popular decision among many parents and carers, ReachOut research shows that the majority of young people aged 12–15 (72%) disagree with the restrictions or have mixed feelings about them.

Many young people may struggle with accepting the restrictions and could find it difficult to manage the period of transition away from social media. This guide is designed to help you better understand how this change may affect your teen's emotions and wellbeing, and to suggest some ways you can support them to navigate the transition.

## Understanding the impacts

While there are many expected benefits to staying off of social media, your teen may only be considering what they are set to lose.

Social media is a core element of teen friendships today. It's the most common way to chat with friends, to make new friends, and to keep up to date with each other's lives. Many teens also find connection and comfort in digital spaces.

These benefits are especially valued by teens from marginalised backgrounds, who may struggle to see themselves represented in the physical world around them.

Our research shows that teens also use social media as a way to discover mental health information, often using these platforms as frequently as they would use a search engine like Google.

Delayed access to social media may mean that your teen feels they are losing access to their standard way of communicating with their friends, learning about themselves and connecting with the world around them. They may feel left out, or uncertain about where they fit in, and this could affect their confidence and overall wellbeing.

### Helping teens cope with this change

Change is a normal part of life. It can even help us to develop strengths such as courage, flexibility and resilience. But change can also be overwhelming and confusing. Negative emotions around losing access to social media may not disappear overnight. Talking about things with them will help your teen to process and accept what's happened.

Here are some quick tips for supporting your teen during this time of change:

1. Listen closely, and with empathy, to what they have to say.
2. Don't dismiss or minimise their feelings about the situation.
3. Help them to practise acceptance by discussing what they can and can't control.
4. Encourage positive wellbeing behaviours such as exercise or journaling.
5. Support them to build offline friendships to prevent isolation and loneliness.
6. Find ways to spend positive time offline together as a family.

# Navigating tension and behaviour change

Having the freedom to make your own choices and decisions is an important part of growing from a teen into a capable adult. These restrictions may feel like a big loss of freedom, and your teen may respond by rebelling or blaming you. Teens with older siblings who can still access social media might also feel they're being treated unfairly, which could cause tension within the family.

You might also notice some behaviour changes in your teen during this time. If they've become dependent on social media for their sense of wellbeing, they may experience some withdrawal-like symptoms. This could look like frequent mood swings, withdrawal from family life, disrupted sleep, poor eating habits, or issues with communication (e.g. they might become impatient or short-tempered).

The first step if you notice tension or a behaviour change is to speak openly about it with your teen. Approach the conversation with empathy and patience, and practise active listening so they feel heard and understood.

If your teen is unresponsive or uncooperative, try to have the chat again after they've had some time to reflect. If they are really struggling, it might be time to seek professional help.

## Professional support for teens

If you're worried about your teen's mental health and wellbeing, a visit to their GP is a great first step in getting help. You could also explore counselling or therapy.

Your teen may be feeling a lot of uncertainty about whether a professional can help them, how to talk about what they're going through, or whether they even need to see someone. A good way to support your teen through this

process is to make sure they're prepared for their appointment. Sit down together and help them write out what they're feeling and experiencing. Encourage them to refer to this list during their appointment.
